


Covenants


2024 Financial Achievements

Croasdaile Village Wellness 2024

Croasdaile Village Wellness continues to provide a variety of classes, interventions, presentations, and special events that highlight each dimension of wellness while considering the interests and goals of Croasdaile Village residents. The highlights of the year include a spring Wellness Fair, Fall Prevention Week, and the Rock 'n' Roll Triathlon.

The Wellness Fair theme was "The Longevity Lifestyle" which drew on the wisdom of the Blue Zones and the functional considerations to improve health and fitness in older adults. The topics included the Longevity Lifestyle with Margie Pacher, M.Ed., Nutrition with Kelsey Cherry, R.D., Balance and Fall Prevention with the HealthPro Heritage Therapy Team, Building Strength as You Age with Catherine Doyen, CPT, and Spiritual Wellbeing with Rev. Laurie Hays-Coffman. Residents were provided with information booths facilitated by the Clinic, Home Care, Navigation, Nutrition, and Wellness, and lawn games to enjoy social time with other residents.

Fall Prevention Week included a fall risk assessment with HealthPro Heritage Therapy Team, Balance Bootcamp with Catherine Doyen, CPT, Balance Essentials Presentation with Margie Pacher, M.Ed., Balance Progressions presentation with Catherine Doyen, Reduce Your Falls Risk with Clinical Strategies with Susan Mullis, R.N., and beginner to advanced exercise classes. Residents who participated received a "Fall Prevention is in the Air" long-sleeve t-shirt. Approximately 100 residents participated with 75 participating in the falls risk assessment.

The Rock 'n' Roll Triathlon was a hit with our more active residents. Events included pool walking or swimming, recumbent biking, and walking or jogging Boles Lake. Participants were split between beginner and advanced groups. Each event space had sixties rock 'n' roll music and water stations for residents to hydrate upon transitioning to the next event. Winners received gold, silver, or bronze medals. Fourteen residents completed the triathlon, and several came out to cheer on their favorite triathletes.

Our resident Wellness Committee was a crucial part in making our events successful, from encouraging resident participation to volunteering for a variety of event tasks.

At Croasdaile Village, we remain dedicated to fostering a welcoming community for both living and working. As part of this commitment, we have expanded our career growth and development efforts.

This year, we proudly sponsored five employees to complete the Certified Nursing Assistant (CNA) program and state certification exam. We are delighted to announce that all five successfully passed both the course and the exam. Additionally, one team member achieved the significant milestone of completing the requirements to become a Registered Nurse (RN).

Our healthcare Life Enrichment team had a fantastic year, working to engage our residents in activities that focus on the 8 dimensions of wellness. Residents enjoyed a wide range of outings and events both within the Pavilion and in the community.

Spiritual Life

In September 2024, Cypress Glen's Spiritual Life committee donations totaling \$26,400 were distributed to 18 charitable organizations within the Greenville-Pitt County area. Greenville Wesley, an ECU and PCC campus ministry, was a new recipient this year after an impactful presentation given by their campus minister, bringing awareness to the many ways the organization serves students. The total giving for the fiscal year was \$50,400.

Currently, there are 6-8 resident volunteers who regularly volunteer at the local Joy Soup Kitchen, assisting to address food insecurities throughout Greenville.

Cypress Glen coordinates with Pitt Community College (PCC) and East Carolina University (ECU) to contract for a current performing arts/music department student to fulfill the community's need for a Sunday worship service choir director. This is mutually beneficial to the student, who is compensated for these services, and to Cypress Glen.





Staff Growth & Honors

Social Services Director Katie Paul completed 3,000 clinical hours and passed her state licensing exam in July of 2024. She is now a North Carolina board-certified Licensed Clinical Social Worker. Katie has more than 20 years of service at Cypress Glen and combined with her passion for the mental health treatment of older adults, this will add another layer of expertise to the services she provides for Cypress Glen residents. One-on-one psychotherapy with Katie is available as part of the resident monthly service fee, to keep services in house when preferred.

Community Benefit: \$878,773

Cypress Glen provides benevolent assistance to residents who, through no fault of their own, can no longer meet their financial obligations.

As has been our history, Cypress Glen partnered with six local schools to serve as a clinical site for their CNA programs and provided 8,142 total clinical hours for the students. It has been commonplace for these students to later apply for staff positions due to their positive experience.

Staff scholarships are awarded for spring and fall semesters each year. In 2024, the following staff members earned scholarships:

Table Scholar Award: Abby Paul, a waitstaff member, is attending ECU to pursue a degree in recreation therapy. She has worked at Cypress Glen since 2020. A second Table Scholar recipient is waitstaff member Madison Bowen who is also attending ECU to pursue a degree in recreation therapy. She has been employed at Cypress Glen since 2021.

The Margaret Mansfield Scholarship:

Jylnn Burney, a Medication Technician and C.N.A. is attending Lenoir Community College to become a licensed nurse. Jylnn has worked at Cypress Glen since 2021.

The Vera and Chip Pennington Scholarship:

Cedrick Lee, C.N.A., is attending Pitt
Community College to become a registered
nurse. He completed his clinical work to
become a C.N.A. at Cypress Glen and then
joined the Cypress Glen team in early 2024.
Also receiving the Pennington Scholarship is
Holly Rigsbee, a waitstaff member, who joined
the dining staff in early 2024. She plans to go
to graduate school to become a physical
therapist, with an interest in taking care of
cancer patients.

The Staff-to-Staff Scholarship: Part-time front desk clerk Laurie Maloney is enrolled in the Northcentral University's Doctor of Philosophy in Psychology program. Laurie has worked in her role since early 2020. She is interested in the prevention of elder abuse and is currently drafting her dissertation on recognizing risk factors associated with the enablement of existing abuse.

Cypress Glen awarded scholarships to two certified nursing assistants which they are using to attend nursing school. The community strives to support the staff with their personal and professional growth.



Dining News

Dining services recently concluded a year of an extraordinarily successful Chef's Special program. The program was developed to generate excitement among our residents in the form of new and interesting menu items. The dining team utilized their collective creativity to craft high end, plated entrees in addition to the existing main course choices on our four-week menu cycle. The response was fantastic, and residents continue to appreciate the more adventurous offerings on the menu. Taco Tuesdays and burger Thursdays have also been a big hit, and the international items on the menu have broadened the residents' culinary horizons.

This year saw the return of the Rowdy Bunch, a festive monthly gathering of residents for food and fellowship. A Cypress Glen couple founded The Rowdy Bunch more than 25 years ago as a weekly gathering for attendees to meet and dine with other residents whom they may not have had the opportunity to meet. The popularity of this group quickly grew and was consistently well-attended until the gathering paused in 2020. Upon resurrection this year, it is again a tremendous success due to the impressive resident entertainment and top-notch meals from the dining team.

Another notable return to Cypress Glen has been the ECU Club dinners where residents gather for a fine dining style coursed meal, accompanied by musical entertainment and a presentation relevant to East Carolina University. Many residents have ties to ECU and appreciate an opportunity to don their purple and gold in support of their beloved school. Guest speakers from various university entities present interesting programs to further educate the audience on ECU's growth and accomplishments. Dining services create and present an incredible meal as an added attraction for these quarterly events.

Life Enriching Activities

The Life Enrichment Department has joined forces with Lifeloop, a comprehensive software platform designed to deliver quality experiences for residents. Two large screen mobile monitors were purchased to display the digital programs, delivering wellness-focused content to engage and entertain the residents in memory care and long-term care/short-term skilled nursing. The Lifeloop programming also offers valuable learning opportunities and challenging games for Independent Living residents.

Campus Enhancements

A renovation to the Independent Living D Wing patio was completed in 2024, increasing the size and giving it a fresh look. The patio includes new hardscaping, perimeter landscaping, integrated underlighting, new tables and chairs, and a gas grill for residents' use.

A new outdoor sporting area was designed and completed this year for residents to enjoy a little friendly competition or hone their skills. Residents can relax with horseshoes, cornhole with custom granite tops, a putting green, and a shuffleboard court.

The Barnes Private Dining Room is a popular gathering spot for meetings, card games, special celebrations, and for groups wanting an intimate dining experience. The space, which comfortably accommodates twenty-eight people, was given a makeover this year with a fresh look and contemporary furniture.

Several departments appreciate GEM electric vehicles to perform their duties. Marketing, security, and housekeeping utilize these attractive, efficient cars. These high quality, electric service vehicles add more versatile capabilities to our service fleet, as opposed to traditional golf carts. The appearance of these vehicles creates a positive first impression for visitors, while providing safe and comfortable transportation about the sprawling campus

Marketing & Sales

The South Wing Independent Living apartment building expansion construction project added an exciting element to regular marketing efforts. The 57 apartments sold out in March and the buyers and current residents actively attended monthly Hard Hat presentations given by the contractor and development team. The project timeline remains on track for completion in December 2025. There are six different open-concept floor plans varying in size from 1,080 to 1,900 square feet. Each apartment will have a patio or balcony and underbuilding parking.

Marketing staff met with each of the buyers throughout the summer to make finish selections for their new apartment. A member of the Blum Construction team was on hand for technical construction questions. The process went smoothly and was completed in early September. The South Wing building will connect to the existing community using an interior hallway past a new auditorium and a new restaurant-style dining venue and wine bar, all currently under construction. There is great resident excitement surrounding the new facilities. Additional construction projects within the current main building begin in January 2025.

Community Benefit

Wesley Pines strives to give back to the local area understanding the value of creating goodwill and networking within the community. Ways include participating as Ambassadors for the Lumberton Chamber of Commerce, a longtime sponsor for the Lumberton Area Chamber of Commerce Annual Golf Tournament and the Christmas Parade as well as volunteering at both events. Wesley Pines offers meeting spaces for two local Girl Scout Troops, Second Time Around band practice, and The Oaks Homeowner's Association meetings.

Over the past year, Wesley Pines has offered clinical teaching space for future healthcare workers from the University of North Carolina at Pembroke, Robeson Community College, and local high schools. The institutions have used the community as hands-on learning sites to educate nursing and certified nursing assistant students. From January to April 2024, Physician Assistant students from Methodist University shadowed various healthcare team members to gain knowledge in long-term care.

Wesley Pines is a season sponsor for the Carolina History Civic Center in Lumberton, the Givens Arts Center at the University of North Carolina at Pembroke. Both venues offer musicals, local talent performances, concerts, and guest speaker series which residents enjoy attending. The community also sponsors local non-profits and community organizations such as Kiwanis and Beast Fest in the neighboring town of Bladenboro. As a token of appreciation, Wesley Pines provided Police Appreciation gifts to the officers of the Lumberton Police Department presented by Mrs. Kimberly Walters, Marketing Director.



For several years now, Wesley Pines has partnered with Hickory Grove Baptist Church of Bladenboro to be a host location for dropping off donations for Operation Christmas Child which is part of the Samaritan's Purse. Jessica Stanley, who serves as the Healthcare Admission Director has also volunteered to help pack shoeboxes at the Operation Christmas Child Packing Center in Charlotte, North Carolina.

The community partnered with Blood Connection to serve as a blood donation site. The blood drives occurred three times in the past year. At each drive the goal was met or exceeded for donations.

Wesley Pines provides benevolent assistance to residents who, through no fault of their own, can no longer meet their financial obligations.

Healthcare

Wesley Pines began a partnership with Eventus Whole Health in April 2022 which continues to grow and expand. Eventus provides both customized primary care and mental health services to residents and most recently began offering psychotherapy services. In the Spring of 2024, the community welcome the return of Dr. Rhonda Lowry as Medical Director. Mrs. Brandie Jacobs, FNP, continues to serve residents on site four days a week and Mrs. Nickey Dimery, FNP, provides mental health services one day per week. As this collaboration continues to grow, the benefit is the improvement in the lives of our residents through greater access to medical care.

Administration

Mrs. Karen Cribb, RN, Director of Nursing, has served on the Career Employment Council since September 2022. The council consists of the Public Schools of Robeson County, Robeson Community College, the University of North Carolina at Pembroke, and area businesses. The collaborative group was formed as a way that each educational establishment could learn what the workforce is seeking. Wesley Pines in turn serves as clinical sites for these educational establishments.

During the past year, Ms. Amy Shooter and Mr. Charles Davis, Plant Operations Director participated in a tabletop Emergency Preparedness Trainings provided by Duke Emergency Preparedness Coalition. The tabletop exercise focused on how to respond to cold weather emergencies and determine when to shelter in place or evacuate residents and staff.

In January 2024, Mrs. Cynthia Woodell was chosen as the Environmental Services Supervisor. Cynthia was a Food and Beverage team member who had been with the community for several years. Since beginning the new role, Cynthia has focused on learning each role in her department so that she can successfully lead her team. She is a graduate of Robeson Community College and resides in Lumberton.





Wellness & Community Life

Our Community Life Services team has kept residents engaged with great activities and events that our residents enjoyed. Crafts have made a comeback with residents enjoying painting projects. Our residents have gone on many lunch and shopping trips to neighboring towns, mystery rides, and concerts at the Carolina Civic Center to hear groups such as The Drifters. During spring and summer months, the team had ice cream socials and a watermelon social. One of the new programs introduced was the Fit, Fab, & Fun exercise program that is resident led by two independent living residents and an assisted living resident. Other new volunteers include new singers and a new Bible Study leader.



Jill is a Lumberton native, is a New York Times bestselling author, has taught at UNC-Chapel Hill, Tufts, and Brandeis.

Other notable communitywide activities over the past year were Pink out For Breast Cancer, World Day of Prayer, the Kick It for Parkinson's Walk, and the Walk to End Alzheimer's. One of the most exciting weeks in the health center is National Nursing Home Week in which each department hosted an activity each day of the week that showcased each department's hidden creativity. The community also celebrated National Assisted Living Week with a carnival and Assisted Living Open House and International Active Aging Week with a guest speaker from the Robeson County Extension Agency.

Wesley Ridge is a 24-unit one- and twobedroom apartment community located adjacent to the Wesley Pines campus in Lumberton, N.C. Wesley Ridge is a division of UMRH Affordable Housing.

The Wesley Ridge community has six, one-story buildings constructed of wood frame, vinyl siding, and brick veneer. Each building contains four apartments: Three one- bedroom units of approximately 625 square feet and one two-bedroom unit of approximately 840 square feet. Wesley Ridge is open to senior adults age 62 and older and to persons 18 years of age and older with disabilities. To become a resident, persons must earn no more than 60% of the median income in Robeson County, N.C. This translates to approximately \$30,840 for a single person and \$35,220 for a couple. Residents of Wesley Ridge have access to Wesley Pines Health Center should the need arise. The community is managed by Partnership Property Management (PPM), of Greensboro, N.C., and Florence, S.C. The community has an Advisory Board which meets twice annually. Robin Sagendorph is the manager of the community, and Mrs. Teresa Lawson is the property manager. Admission is on a first-come, first-serve basis. Applicants must pass a security check, drug test, and credit check.

Scholarships

Croasdaile Village Scholarships

The late Dr. Jack & Betty Fassett, Croasdaile Village residents, established the John D. Fassett Endowment for Dining Services Employee Scholarships in 2001. Since this scholarship's inception, 171 scholarships have been awarded for a total of \$192,000. Beginning in 2016, Dr. Fassett increased each award from \$1,000 to \$1,500 to account for inflation since the first awards were made in 2004. Other residents have made significant contributions to the fund over the years so that no qualifying applicant would be rejected. We are grateful to all who choose to donate to this fund to make these awards possible.

The late Dr. Garland Knott established the Kathleen Knott Scholarships in Healthcare Education in appreciation for the loving care his late wife, Kathleen, received in the Pavilion Healthcare Center in 2004. Since this scholarship's inception, 84 scholarships have been awarded for a total of \$49,425. Dr. Knott, who was a Croasdaile Village resident, contributed \$1,800 every year to fund three scholarships. He funded these annual gifts through a charitable gift annuity (CGA), giving him excellent tax advantages and payout rate. The CGA remainder was used after his death to establish the Garland and Kathleen Knott Scholarships in Healthcare Education Endowment. Other donors give to the scholarship fund so that no qualifying applicant is turned down. Earnings from the Endowment will also fund scholarships.

The Matthews Scholarship awards are made possible by Mrs. Kathleen Matthews and other Croasdaile Village resident donors and was founded in 2013. Since this scholarship's inception, 42 scholarships have been awarded for a total of \$42,000. Matthews Scholarships are open to qualifying employees enrolled in any curriculum as approved by the UMRH Foundation Scholarship Committee. The late Mr. & Mrs. Edward C. & Betty M. Matthews made provisions through a charitable remainder trust to fund the Edward C. and Betty M. Matthews Employee Scholarship Endowment.

Cypress Glen Scholarships

The Cypress Glen Employee Scholarships were awarded in August in the amount of \$750 each. These scholarships are funded by gifts from Cypress Glen management, senior staff and residents. The Cypress Glen Residents' Council made a major gift in support of these scholarships. The Vera and Chip Pennington Employee Scholarships are planned for December. Mr. Pennington funded the Vera and Chip Pennington Employee Scholarship Endowment through a charitable gift annuity remainder.

The Margaret Mansfield Employee Healthcare Scholarships established by the family of the late Margaret Mansfield has been a great resource for employees of Cypress Glen.

The Ernest & Marjorie Wright Staff Education & Training Endowment is another asset at Cypress Glen. The late Marjorie and Ernest Wright were longtime residents of Cypress Glen who wanted to have a lasting impact on their community. They did this through a very significant gift specified in their estate plan. The purpose of the endowment is to provide for staff education and training, including an employee scholarship program.

Wesley Pines Scholarship

Our newest scholarship is the Louie M. and Maxine Locklear Amos Scholarship at Wesley Pines. This scholarship provides assistance to employees of Wesley Pines, who are pursuing further education.

Get Involved

Here are a few ways to support the mission of the Foundation: Many donors make outright gifts of cash, securities, and other assets for projects that improve the quality of life of residents. - Time to part with your car? Let us take care of it for you. From time to time, we receive a car from a resident and post the car for sale internally within the community so that an employee can buy it. It's a win-win-win. You get to write off the value of the automobile, the employee gets reliable transportation at an affordable price, and we get funds to support benevolent care.
- Naming opportunities are available to those who wish long-term recognition of friends or loved ones. Naming's can be associated with physical facilities, or with endowment funds, scholarship funds, and other nonphysical assets.
- Unrestricted gifts are the most flexible type of support, allowing Trustees to approve them for use where needed most.

Consider a future gift:

- Consider adding UMRH as a beneficiary in your will, IRA, or life insurance policy.
- Set up a Charitable Gift Annuity through the Foundation that will provide you with a guaranteed income, tax benefit, and a donation to the Foundation later on.
- Work with your estate attorney to create a Charitable Remainder Trust. UMRH acts as a trustee to several trusts and also acts as a beneficiary to several others.

What advice would you give others?

I'd say the best thing to do would be to get involved with the things that interest you. Meet people who enjoy the things you like and that's a great place to start.

Sharron also supports many other charities including ones that help with food insecurity, homelessness, animal well-being, environment preservation, medical work & research, and the health of our veterans.
